Directors Report (Saldaña/Burson/Baños)—

- 1. The RPHS Band is adding a 3rd Band Director position to its staff!
 - a. We have already interviewed and hired for the position and will announce the candidate once it is approved by FBISD Human Resources
- 2. Request for Reimbursement Motion Labs "Rac Pac 2RU Edison Duplex also located in Treasurer Section for ratification
 - a. \$878.94 payable to Sarah Saldaña
 - b. This allows the new sound system to operate at 100 percent power capacity by converting it's 240 watt energy to be used by regular 120 watt outlets. Operating the sound system without this will cause the system to short (and potentially catch fire) the power outlet (generator or school) used for the sound system.

 - o Our main checking account has been updated to a Preferred Business account. This will allow us to deposit cash and not get a service fee.
 - A bank associate recommends that we move a good chunk of the money in the Checking account to the Savings account. Motion to move \$100,000 to the Savings account. Motioned by Luis Saldaña and seconded by Kristen Blomstrom. Motion was approved.
- Glenda Procter now has access to JotForm. She will be able to order the band/guard supplies that have been selected.
- Passwords on PayPal and Square Accounts. My recommendation is that each year the password should be changed. I had a former Treasurer contact me because she almost ordered something using our PayPal account. Agreed that this will be implemented.
- Our insurance has been updated and paid.
